

**BEFORE THE ARKANSAS BOARD OF REGISTRATION FOR
PROFESSIONAL ENGINEERS AND LAND SURVEYORS**

Case #2007-18, in the matter of Charles Alsberg & NAHC:

COMPLAINT

The Arkansas Board of Registration for Professional Engineers and Land Surveyors (hereinafter "the Board") received a complaint on June 6, 2008, charging Charles Alsberg (non-registrant, hereinafter "Alsberg") representing North American Hydro Contracting, LLC (non-registrant, hereinafter "NAHC") with conducting an engineering investigation into the causes of a project failure in Arkansas without registration, in violation of Arkansas Code Annotated §17-30-102.

FINDINGS OF FACT

1. In the general area of Batesville, AR, there are three locks on the White River, all under the control of Independence County. Independence County (IC) decided to place hydroelectric power-generating equipment in the lock chambers, and to wholesale the resulting power.

2. IC entered into a series of contracts with North American Hydro Contracting (NAHC) to provide the design work and equipment for this project. NAHC farmed the design work out to an engineering firm (Hatch-Acres Corporation, AR-COA #631), but retained management control of the project, including acquisition of the necessary equipment.

3. The project is more or less complete and the generators are turning, but it has not met its revenue generation projections due to less-than-anticipated production.

4. After a preliminary evaluation of the problem suggested intake headloss resulting from adverse currents and turbulence, NAHC made measurements and other investigations into the condition of the river channel upstream of the intake.

5. That investigation data was provided to Hatch-Acres, who relied upon the data to conclude the contract deliverable of cleaning out and grading the river channel was improperly or incompletely done, with the resulting adverse currents and turbulence the direct cause of the lower-than-anticipated generator output.


CONCLUSIONS OF LAW

Upon review of the evidence in its possession, the Board finds NAHC's actions as described in the Findings of Fact do not constitute violation of the statutes or rules governing the Arkansas Board of Registration for Professional Engineers and Land Surveyors.

ORDER

Based on these findings, the complaint against Alsberg and NAHC is dismissed without further action by the Board.


