## MEETING MINUTES BOARD MEETING August 15, 2014

A regular meeting of the Arkansas State Board of Public Accountancy (Board) was held in Suite 450 of the Main Street Mall on August 15, 2014 with Karen Garret, President, presiding. Other members of the Board in attendance were: Wade Turner, Jeremy Watson, Michael Moore, Robert Redfern, Lloyd Franklin, and Jim Gately. Members of the staff in attendance were: Jimmy Corley, Executive Director; Dale Edge, Board Investigator; Tim Montgomery, Board Investigator; Alan Fortney, IT Manager; April Murphy and Angela Johnson. ### CALL TO ORDER

Karen Garrett officially called the meeting to order at 9:05 a.m. A quorum was found to be present.

### PUBLIC HEARINGS

The Board moved immediately to Public Hearings concerning cases H14-009, H14-035, H14-055, and H14-056.

**H14-009** involved the failure to renew an individual license or notify the Board of the intent to surrender the license as well as failure to respond to Board communications. All allegations were found to be true and the charges were proven. The CPA's license was revoked by the Board.

**H14-035** involved the failure to renew an individual license or notify the Board of the intent to surrender the license as well as failure to respond to Board communications. All allegations were found to be true and the charges were proven. The PA's license was revoked by the Board.

**H14-055** involved an application for reinstatement by a CPA whose license had been previously revoked by the Board. The Board found that the applicant did not lack good moral character substantially connected to the professional responsibilities of a licensee. The Board agreed to reinstate the applicant subject to the completion of 120 hours of CPE (60 hours of which must be in class and cover Accounting/Attest topics) as well as submission of future audit and review reports for pre issuance review by another CPA approved by the Board.

**H14-056** involved the failure of a CPA to pay fines assessed at a previous hearing. All allegations were found to be true and the charges were proven. The CPA's license was revoked by the Board.
