### ARKANSAS CONTRACTORS LICENSING BOARD

vs

### BIG HAMMER CONTRACTORS LLC

#### ORDER

The Board voted unanimously that the license of BIG HAMMER CONTRACTORS LLC is hereby revoked for misconduct. BIG HAMMER CONTRACTORS LLC shall refrain from bidding on or performing work on any commercial projects in the amount of \$50,000.00 or more prior to being licensed with the Contractors Licensing Board.

#### ORDER

The Board voted unanimously that the license of HURST CONCRETE CONSTRUCTION, INC. is hereby revoked for misconduct. HURST CONCRETE CONSTRUCTION, INC. shall refrain from bidding on or performing work on any commercial projects in the amount of \$50,000.00 or more prior to being licensed with the Contractors Licensing Board.

### BENETZ CONSTRUCTION, INC.

#### ORDER

The Board voted unanimously that BENETZ CONSTRUCTION, INC. shall pay a civil penalty of \$5,660.00 for violation of Act 150; \$18,869.00 for violation of Act 162 as amended for a total of \$24,529.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in the amount of \$50,000.00 or more prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
