#### **ORDER**

The Board voted unanimously that the license of River City Construction LLC is hereby revoked for fraud or deceit in obtaining a license. River City Construction LLC shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

#### **ORDER**

The Board voted unanimously that Billy McGee, d/b/a Northeast Arkansas Fences shall pay a civil penalty of \$1,196.00 for violation of Act 150; \$1,196.00 for violation of Act 162 as amended for a total of \$2,392.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

### **SPLASHTACULAR, INC.**

days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.
