**ARKANSAS CONTRACTORS LICENSING BOARD**

**vs.**

**TONY MALLORY PLUMBING, INC.**

**ORDER**

The Board voted 4 to 2 that Tony Mallory Plumbing, Inc. was in violation of Act 150 but assessed no penalty; and was in violation of Act 162 but assessed no penalty. Tony Mallory Plumbing, Inc. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted 4 to 2 that Doug Gilmore shall pay a civil penalty of \$4,580.55 for violation of Act 150; \$4,580.55 for violation of Act 162 as amended for a total of \$9,161.10 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

**TNT CONSTRUCTION, INC.**

**ORDER**

The Board voted 5 to 1 that the license of TNT Construction, Inc. is hereby revoked and that the Board will not consider the application of TNT Construction, Inc. for 3 months. TNT Construction, Inc. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
