#### ORDER

The Board voted unanimously that Alan Loyd Hefley, d/b/a Hefley Swimming Pools shall pay a civil penalty of \$3,668.00 for violation of Act 150; \$3,668.00 for violation of Act 162 as amended for a total of \$7,336.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

#### ORDER

The Board voted unanimously that T.V. Wallis was not in violation of the Arkansas Contractors Licensing law. T.V. Wallis shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
