The Board voted unanimously that Kenny Graham, d/b/a K.G. Roofing Company; K.G. Roofing & Construction shall pay a civil penalty of \$1,380.00 for violation of Act 150; \$1,380.00 for violation of Act 162 as amended for a total of \$2,760.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
