**ARKANSAS CONTRACTORS LICENSING BOARD**

**vs.**

**AUGUSTINE T. GONZALES**

**ORDER**

The Board voted unanimously that Augustine T. Gonzales shall pay a civil penalty of \$1,650.90 for violation of Act 150; \$1,650.90 for violation of Act 162 as amended for a total of \$3,301.80 reduced to \$1,650.90 if licensed within 120 days to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

**DOUG GILMORE**

**ORDER**

The Board voted 4 to 1 that Doug Gilmore shall pay a civil penalty of \$1,996.23 for violation of Act 150; \$5,323.28 for violation of Act 162 for a total of \$7,319.51. This amount shall be reduced to \$4,657.87 if Doug Gilmore is licensed within 120 days, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

**INSULATION SYSTEMS, INC.**

**ORDER**

The Board voted 4 to 1 that Insulation Systems, Inc. shall was in violation of Act 150 but assessed no penalty. Insulation Systems, Inc. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

**JASON SQUIRES, D/B/A SBS CONSTRUCTION**

**ORDER**

The Board voted unanimously that Jason Squires, d/b/a SBS Construction shall pay a civil penalty of \$672.78 for violation of Act 150 and authorizes the issue of an order of abatement on any future unlicensed project. The penalty is payable to the Board within five (5) days of receipt of this Order and Jason Squires, d/b/a SBS Construction shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
