

**MINUTES OF THE ARKANSAS MOTOR VEHICLE COMMISSION**

**Business Meeting

**March 18, 2020**

The regularly scheduled meeting of the Arkansas Motor Vehicle Commission was called to order via conference call at 9:30a.m. by Chair Joy Blankenship. Staff present included Sandy Stroope, Tanelle Hymes, Crystal Campbell, Robert Galloway, and John Carmack. All the Commissioners were on the call except for Rick Whitten and Ken Yarbrough. Also present on the call was Julie Chavis with the Attorney General's Office, Greg Kirkpatrick with AADA, and Courtney Sheppard and Randy Thurman with Government Solutions and Clay Smith with the Governor's office.

The minutes from the December 18, 2019, meeting was unanimously approved following a proper motion and second.

The Commission approved the meeting expenses for the current meeting following a proper motion and second.

Sandy Stroope presented the Executive Director's Reports. Julie Chavis with the Attorney General's Office updated the Commission on current Ad Hoc findings/actions with one being from a previous hearing with Ford Motor Company and two more to discuss following the meeting.

Director Sandy Stroope introduced the new Commissioner Michael Moix. The Commission then reviewed and approved Consent Orders H#20-001 J & J Water Sports, H#20-002 Bentonville BMW, H#20-003 Triple C Sales, H#20-004 Ghetto Works Marine and More, H#20-006 Riggs Outdoor, H#20-007 Godfather's Powersports, H#20-008 Southwest Outdoor Center, H#20-009 Ryburn Motor Company, H#20-011 Jones Auto Source, as presented.

Chair Joy Blankenship thanked the subcommittee which consisted of herself, Jimmy Jones, Mitch Ward, and Duane Neal, for coming together and providing a very careful thought and consideration to all applicants who submitted a 2020 Education & Training Grant application. Crystal Campbell added that only fourteen out of the eighteen applicants were selected for a grand total of \$199,995.98. Some of the applicants are first-time recipients and others are repeats, but they all are able to match the funds and show

documentation. The Commission approved and gave proper motion and second.

Director Sandy Stroope gave the Commission the transformation update.

Chairman Blankenship accepted a proper motion and a second to adjourn the meeting.
