

**MINUTES OF THE ARKANSAS MOTOR VEHICLE COMMISSION**

The regularly scheduled meeting of the Arkansas Motor Vehicle Commission was called to order via Zoom conference call at 9:30a.m. by Chair Joy Blankenship. Staff present included Sandy Stroope, Rob Galloway, and John Carmack. The Commissioners present are Joy Blankenship, Foster "Jock" Davis, Duane Neal, Michael Moix, Jimmy Jones, Scott Wood, Jean Campbell, and Mitch Ward. Also present on the call was Julie Chavis with the Attorney General's Office, and Greg Kirkpatrick with the AADA.

The minutes from the April 21, 2021, meeting was unanimously approved following a proper motion and second.

The Commission approved the meeting expenses for the current meeting following a proper motion and second.

Ken Anderson with the Department of Labor and Licensing IT department introduced Enterprise Licensing and Permits (ELP), as a replacement for the AMVC's current database. The Commission approved following a proper motion and second.

Julie Chavis with the Attorney General's Office presented AD Hoc Finding and asked the Commission for 2 \$250.00 fines to the offending dealer. The Commission approved the fines following a proper motion and second.

The Commission moved to Hearing H#21-007, AMVC vs. Central Arkansas Mahindra, H#21-013, AMVC vs. Arkansas RV Sales & Service, H#21-014, AMVC vs. White River Powersports, H#21-016, AMVC vs. Taylor Made Ambulances. The Commission hereby revokes the dealer license of Central Arkansas Mahindra, Arkansas RV Sales & Service, White River Powersports, and Taylor Made Ambulance, following a proper motion and second.

The Commission then reviewed and approved Consent Orders H#21-011 Beebe Lawn & Power Equipment, H#21-012 Tedder Equipment of NEA, H#21-017 Hustler Turf and Equipment, as presented.

Director Stroope presented to the Commission the Monthly Director's Reports. He also reported that Investigator Campbell has left the agency and the AMVC has advertised to fill the vacant position. Act 504,

regarding Salesperson Licensing & Automotive Technologist Education Grant Fund, was discussed. This Act eliminates salesperson licensing by the AMVC and changes how the Grant fund will work in the future. Director Stroope also addressed ACT 1077, and how it will affect the Commission.

Chairman Blankenship accepted a proper motion and a second to adjourn the meeting.
