ARKANSAS CONTRACTORS LICENSING BOARD

VS

TWIN LAKES ROOF SYSTEMS, LLC

ORDER

The Board voted unanimously that Twin Lakes Roof Systems, LLC shall pay a civil penalty of \$12,800.00 for violation of Act 150; \$15,510.00 for violation of Act 162 as amended for a total of \$28,310.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

STEVEN CORBIN, D/B/A CORBIN ROOFING

ORDER

The Board voted unanimously that Steven Corbin, d/b/a Corbin Roofing shall pay a civil penalty of \$1,694.00 for violation of Act 150; \$2,259.00 for violation of Act 162 as amended for a total of \$3,953.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

VS

CHARLES PIGGEE, D/B/A PIGGEE PROFESSIONAL BUILDERS

ORDER

The Board voted unanimously that Charles Piggee, d/b/a Piggee Professional Builders shall pay a civil penalty of \$10,500.00 for violation of Act 150; \$17,500.00 for violation of Act 162 as amended for a total of \$28,000.00 to the Board, payable within twenty (20) days of receipt of this Order. The Board further ordered that a Cease and Desist Order be issued against Charles Piggee, d/b/a Piggee Professional Builders preventing him from performing work in violation. Charles Piggee, d/b/a Piggee Professional Builders shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ARKANSAS CONTRACTORS LICENSING BOARD

VS

ROBERT LEES, MODE HOME, LLC AND MODE CORPORATION

ORDER

The Board voted unanimously that Robert Lees, Mode Home, LLC and Mode Corporation shall pay a civil penalty of \$30,812.00 for violation of Act 150; \$102,708.00 for violation of Act 162 as amended for a total of \$133,520.00 to the Board, payable within twenty (20) days of receipt of this Order. The Board further ordered that a Cease and Desist Order be issued against Robert Lees, Mode Home, LLC and Mode Corporation to prevent them from performing work in violation. Robert Lees, Mode Home, LLC and Mode Corporation shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
