ORDER

The Board voted unanimously that Billy McGee, d/b/a Northeast Arkansas Fences shall pay a civil penalty of \$400.00 for Act 150 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

JIM MITCHELL, D/B/A ASPHALT & CONCRETE SERVICES AND DALLAS PAVING COMPANY

ORDER

The Board voted unanimously to set aside the previous settlement agreement in this matter and that Jim Mitchell, d/b/a Asphalt & Concrete Services and Dallas Paving Company shall pay a civil penalty of \$2,000.00 for violation of Act 150; \$11,962.00 for violation of Act 162 as amended for a total of \$13,962.00 to the Board, payable within twenty (20) days of receipt of this Order. The Board further ordered that a cease and desist order be issued against Jim Mitchell, d/b/a Asphalt & Concrete Services and Dallas Paving Company to prevent him from performing work in violation. Jim Mitchell, d/b/a Asphalt & Concrete Services and Dallas Paving Company shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
