**ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE**

**vs**

**CHRISTOPHER WAHL, D/B/A BULLDOG CONSTRUCTION**

### **ORDER**

The Committee voted unanimously that CHRISTOPHER WAHL, d/b/a BULLDOG CONSTRUCTION shall pay a civil penalty of \$400 per day for 10 days for a total of \$4,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against CHRISTOPHER WAHL, d/b/a BULLDOG CONSTRUCTION to prevent them from performing work in violation. CHRISTOPHER WAHL, d/b/a BULLDOG CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

### **FINDINGS OF FACT**

The Committee voted unanimously that MICHAEL JEFFERY, d/b/a MIKE'S CONSTRUCTION shall pay a civil penalty of \$400 per day for 7 days of activity for a total of \$2,800 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against MICHAEL JEFFERY, d/b/a MIKE'S CONSTRUCTION to prevent them from performing work in violation. MICHAEL JEFFERY, d/b/a MIKE'S CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

The Committee further ordered that a cease and desist order be issued against ROBERT WALLEY, d/b/a THE IRON SHOP OF ARKANSAS to prevent them from performing work in violation. ROBERT WALLEY, d/b/a THE IRON SHOP OF

ARKANSAS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

RALPH WITHER, d/b/a WITHERS CORE LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee

The Committee further ordered that a cease and desist order be issued against JOSH MCDONALD, d/b/a BIG J'S HANDYMAN & MORE to prevent them from performing work in violation. JOSH MCDONALD, d/b/a BIG J'S HANDYMAN & MORE shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee

SAM HARTER, d/b/a LIFE MADE NEW MINISTRIES shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee

The Committee further ordered that a cease and desist order be issued against AUSTIN SELEE, d/b/a MOARK CONSTRUCTION to prevent them from performing work in violation. AUSTIN SELEE, d/b/a MOARK CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee

The Committee further ordered that a cease and desist order be issued against RON YUNG, d/b/a APEX TECHNOLOGIES, A/K/A APEX HOMES TECH to prevent them from performing work in violation. RON YUNG, d/b/a APEX TECHNOLOGIES, A/K/A APEX HOMES TECH shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

days. The Committee further ordered that a cease and desist order be issued against ELSTON FORTE, d/b/a ELF CONTRACTORS to prevent them from performing work in violation. ELSTON FORTE, d/b/a ELF CONTRACTORS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee
