ORDER

The Board voted unanimously that Zachary & Associates, Inc., d/b/a Zachary Construction shall pay a civil penalty of \$1,468.00 for violation of Act 150 to the Board payable within twenty (20) days of receipt of this Order. The Board further ordered that a cease and desist order would be issued on any future work performed by Zachary & Associates, Inc. d/b/a Zachary Construction in violation. Zachary & Associates, Inc. d/b/a Zachary Construction shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

ORDER

The Board voted unanimously that Eddie Long shall pay a civil penalty of \$1,356.00 for violation of Act 150; \$1,356.00 for violation of Act 162 as amended for a total of \$2,512.00, after the application of a previous payment, to the Board. This amount is payable within twenty (20) days of receipt of this Order and Eddie Long shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
