vs.

SUPREME QUALITY BUILDERS, LLC

ORDER

The Committee voted unanimously that Supreme Quality Builders, LLC shall pay a civil penalty of \$4,680.00 for violation of Act 950 payable to the Committee within twenty (20) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
