A hearing on the above captioned matter was held before the Arkansas Residential Contractors Committee on April 24, 2024, at the Committee's offices at 4100 Richards Road, North Little Rock, Arkansas.

Respondent, SEICORP CORPORATION was properly notified and did not appear. The Committee was represented by Jonathan Hutto, Attorney. Dewey Watson served as Hearing Officer. From testimony and other evidence presented the Committee makes the following findings of fact and conclusion of law.

**FINDINGS OF FACT**

1. SEICORP CORPORATION is licensed by the Residential Contractors Committee.
2. Our office received a complaint from Gwen Robinson against SEICORP CORPORATION. After reviewing the complaint we determined that the issues were best addressed in civil court.
3. On September 27, 2023, Gwen Robinson received a judgment against Kenneth Shelton, individually, and doing business as SEICORP CORPORATION. He was ordered to pay Ms. Robinson \$191,504.47. We sent correspondence to Seicorp asking how they intended to satisfy the judgment. To date, the judgment remains outstanding.

**CONCLUSIONS OF LAW**

SEICORP CORPORATION is guilty of violating Section 17-25-510(c) misconduct in the contractor's business.

**ORDER**

The Committee voted unanimously that the license of SEICORP CORPORATION is revoked for misconduct. The Committee further ordered that a cease and desist order be issued against SEICORP CORPORATION to prevent them from performing work in violation. SEICORP CORPORATION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

A hearing on the above captioned matter was held before the Arkansas Residential Contractors Committee on April 24, 2024, at the Committee's offices at 4100 Richards Road, North Little Rock, Arkansas.

Respondent, ER HOME AND LAWN LLC was properly notified and did not appear. The Committee was represented by Jonathan Hutto, Attorney. Dewey Watson served as Hearing Officer. From testimony and other evidence presented the Committee makes the following findings of fact and conclusion of law.

**FINDINGS OF FACT**

1. ER HOME AND LAWN LLC has undertaken the position of residential contractor as defined in Section 17-25-505, **Multiple Home Improvement Projects in Various Locations, AR.**
2. ER HOME AND LAWN LLC is not licensed by the Residential Contractors Committee.
3. Our office received a complaint from Stacy Gossett stating that she had hired ER HOME AND LAWN LLC to perform a home improvement project and paid \$8,293. ER HOME AND LAWN LLC began the work but abandoned the project prior to completion. There were 12 days of activity on the project.
4. Our office received a complaint from Monty Bradburn stating that he had hired ER HOME AND LAWN LLC to perform a home improvement project and paid \$2,312.50 to the contractor. The work never began and the contractor has failed and refused to return the money.
5. Our office received a complaint from Jennifer Hamel stating she had hired ER HOME AND LAWN LLC to perform a home improvement project and paid her \$6,325.41. Very little work was performed and ER HOME AND LAWN LLC abandoned the project prior to completion. They have failed and refused to return any money. There were 32 days of activity on the project.
6. Our office received a complaint from Isaac Parker stating he had hired ER HOME AND LAWN LLC to perform a home improvement project and paid \$55,000. ER HOME AND LAWN LLC abandoned the project prior to completion and Mr. Parker obtained a default judgment against ER HOME AND LAWN LLC for \$65,000. There were 135 days of activity on this project.
7. On October 16, 2023, Lauren Eason, owner of ER HOME AND LAWN LLC filed bankruptcy and listed these homeowners as nonpriority creditors.

**CONCLUSIONS OF LAW**

ER HOME AND LAWN LLC is guilty of violating Section 17-25-505, as amended.

**ORDER**

The Committee voted unanimously that ER HOME AND LAWN LLC shall pay a civil penalty of \$400 per day for 179 days of activity for a total of \$71,600 for violation of Section 17-25-505

payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against ER HOME AND LAWN LLC to prevent them from performing work in violation. ER HOME AND LAWN LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

4. ELSTON FORTE, d/b/a ELF CONTRACTORS has three previous unpaid violations for working without a license.

**CONCLUSIONS OF LAW**

ELSTON FORTE, d/b/a ELF CONTRACTORS is guilty of violating Section 17-25-505, as amended.

**ORDER**

The Committee voted unanimously that ELSTON FORTE, d/b/a ELF CONTRACTORS shall pay a civil penalty of \$400 per day for 15 days of activity for a total of \$6,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against ELSTON FORTE, d/b/a ELF CONTRACTORS to prevent them from performing work in violation. ELSTON FORTE, d/b/a ELF CONTRACTORS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. The work was extremely poor and there were areas where the structure was not nailed to the concrete and the concrete was poured on the outside of the framing where water would leak. There were 18 days of activity on the project.
4. JERRY CRUMP, d/b/a AMERICAN DESIGN INNOVATIONS had one previous violation for working without a license.

**CONCLUSIONS OF LAW**

JERRY CRUMP, d/b/a AMERICAN DESIGN INNOVATIONS is guilty of violating Section 17-25-505, as amended.

**ORDER**

The Committee voted unanimously that JERRY CRUMP, d/b/a AMERICAN DESIGN INNOVATIONS shall pay a civil penalty of \$400 per day for 20 days of activity for a total of \$8,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. 

2. LESLIE SEELEY, d/b/a SUGARLOAF FARMS is not licensed by the Residential Contractors Committee.
3. Our office received a complaint from Anastasios and Lucinda Dionisiou against LESLIE SEELEY, d/b/a SUGARLOAF FARMS stating they had hired her to perform a home improvement project for \$27,110. They paid her \$22,628 but refused to pay more because of workmanship issues on the project. There were many issues with the work including a damaged culvert and various depths and widths of gravel poured for the road. There were 45 days of activity on this project.
4. LESLIE SEELEY, d/b/a SUGARLOAF FARMS had a previous commercial license that expired on May 31, 2012.

**CONCLUSIONS OF LAW**


LESLIE SEELEY, d/b/a SUGARLOAF FARMS is guilty of violating Section 17-25-505, as amended.

**ORDER**

The Committee voted unanimously that LESLIE SEELEY, d/b/a SUGARLOAF FARMS shall pay a civil penalty of \$400 per day for 45 days for a total of \$18,000 for violation of Section 17-25-505. This amount is reduced to \$4,000 provided there are no further violations for 3 years and they apply for a home improvement license. The penalty is payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against LESLIE SEELEY, d/b/a SUGARLOAF FARMS to prevent them from performing work in violation. LESLIE SEELEY, d/b/a SUGARLOAF FARMS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.
