### **ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE**

**VS**

### **WENDELL BROWN, D/B/A W. BROWN CONSTRUCTION**

#### **ORDER**

The Committee voted unanimously that the license of WENDELL BROWN, d/b/a W. BROWN CONSTRUCTION is revoked for misconduct. The Committee further ordered that a cease and desist order be issued against WENDELL BROWN, d/b/a W. BROWN CONSTRUCTION to prevent them from performing work in violation. WENDELL BROWN, d/b/a W. BROWN CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

### **EDDIE ONEAL, D/B/A ELO ENTERPRISES**

#### **ORDER**

The Committee voted unanimously that EDDIE ONEAL, d/b/a ELO ENTERPRISES shall pay a civil penalty of \$400 per day for 60 days of activity for a total of \$24,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. This penalty shall be reduced to \$200 if EDDIE ONEAL, d/b/a ELO ENTERPRISES pays Denesha Williams back \$24,000 within 60 days. The Committee further ordered that a cease and desist order be issued against EDDIE ONEAL, d/b/a ELO ENTERPRISES to prevent them from performing work in violation. EDDIE ONEAL, d/b/a ELO ENTERPRISES shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.
