vs

BOUNTIFUL ENTERPRISES, LLC, D/B/A AMERICAN WALK-IN TUBS

ORDER

The Committee voted 4 to 1 that the license of BOUNTIFUL ENTERPRISES, LLC, d/b/a AMERICAN WALK-IN TUBS is revoked for gross negligence, incompetence, and misconduct in the contractors business. BOUNTIFUL ENTERPRISES, LLC, d/b/a AMERICAN WALK-IN TUBS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

JOHNNY SPENCE, D/B/A SPENCO ROOFING & CONSTRUCTION

ORDER

The Committee voted unanimously that the license of JOHNNY SPENCE, d/b/a SPENCO ROOFING & CONSTRUCTION is revoked for fraud or deceit in obtaining a license. The Committee further ordered that a cease and desist order be issued against JOHNNY SPENCE, d/b/a SPENCO ROOFING & CONSTRUCTION to prevent them from performing work in violation. JOHNNY SPENCE, d/b/a SPENCO ROOFING & CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.
