#### **RECOMMENDED ORDER**

The Committee voted unanimously to recommend that the license of J. FAGAN CONSTRUCTION, INC. be revoked for misconduct but that the revocation be suspended on the following conditions: there are no further violations for 3 years, they pay any judgment obtained by the homeowner within 90 days, and they submit a renewal application immediately. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.
