**FINDINGS OF FACT,  
CONCLUSIONS OF LAW AND ORDER**

A hearing on the above captioned matter was held before the Arkansas Contractors Licensing Board on October 25, 2024, at the Board's offices at 4100 Richards Road, North Little Rock, Arkansas.

Respondent, SPEEDY GONZALEZ CONSTRUCTION, INC. was properly notified and Antonio Gonzalez did appear to represent the company. The Board was represented by Jonathan Hutto, Attorney. Dewey Watson served as Hearing Officer. From testimony and other evidence presented the Board makes the following findings of fact and conclusion of law.

**FINDINGS OF FACT**

1. SPEEDY GONZALEZ CONSTRUCTION, INC. has undertaken the position of contractor as defined in Section 17-25-101 (Act 150 of 1965 as amended) and Section 17-25-401 (Act 162 of 1987 as amended), **Roofing in Hot Springs, AR.**

2. SPEEDY GONZALEZ CONSTRUCTION, INC. is not licensed by the Contractors Licensing Board.

3. SPEEDY GONZALEZ CONSTRUCTION, INC. has failed to obtain a \$10,000.00 surety bond or cash bond prior to commencing work as a contractor.

4. SPEEDY GONZALEZ CONSTRUCTION, INC. entered into contracts with The Ridge at Lake Hamilton to roof 7 buildings. Each of the contracts were under \$50,000 but they were all entered into on the same day and were for the same project. The total dollar amount of the project was \$109,997.

**CONCLUSIONS OF LAW**

SPEEDY GONZALEZ CONSTRUCTION, INC. is guilty of violating Section 17-25-103, Act 150 of 1965, as amended. (See Act 180 of 1985.)


SPEEDY GONZALEZ CONSTRUCTION, INC. is guilty of violating Section 17-25-408 for failing to comply with the bonding requirements as set out in Section 17-25-404. (See Act 162 of 1987.)

**ORDER**

The Board voted unanimously that SPEEDY GONZALEZ CONSTRUCTION, INC. shall pay a civil penalty of \$3,299 for violation of Act 150 and \$5,499 for violation of Act 162 for a total fine of \$8,798, payable to the Board within twenty (20) days of receipt of this Order. These violations will not trigger the acceleration of the previous penalty provided SPEEDY GONZALEZ CONSTRUCTION, INC. obtains a commercial contractors license within 90 days of the date of this order. SPEEDY GONZALEZ CONSTRUCTION, INC. shall refrain from bidding on or performing work on any projects in the amount of \$50,000.00 or more prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.* You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 25-15-212.
