**FINDINGS OF FACT,
CONCLUSIONS OF LAW AND ORDER**

A hearing on the above captioned matter was held before the Arkansas Contractors Licensing Board on November 15, 2024, at the Board's offices at 4100 Richards Road, North Little Rock, Arkansas.

Respondent, JIMMY PERRY, d/b/a PERRY CONSTRUCTION SERVICES, LLC was properly notified and did not appear. The Board was represented by Jonathan Hutto, Attorney. Dewey Watson served as Hearing Officer. From testimony and other evidence presented the Board makes the following findings of fact and conclusion of law.

FINDINGS OF FACT

1. JIMMY PERRY, d/b/a PERRY CONSTRUCTION SERVICES, LLC has undertaken the position of contractor as defined in Section 17-25-101 (Act 150 of 1965 as amended) and Section 17-25-401 (Act 162 of 1987 as amended), **Demo in Marvell, AR.**
2. JIMMY PERRY, d/b/a PERRY CONSTRUCTION SERVICES, LLC is not licensed by the Contractors Licensing Board.
3. JIMMY PERRY, d/b/a PERRY CONSTRUCTION SERVICES, LLC has failed to obtain a \$10,000.00 surety bond or cash bond prior to commencing work as a contractor.
4. JIMMY PERRY, d/b/a PERRY CONSTRUCTION SERVICES, LLC entered into a contract with the Marvell Elaine School District to perform a demolition project for \$117,081. He did not have a commercial license that would allow him to perform this project.

CONCLUSIONS OF LAW

JIMMY PERRY, d/b/a PERRY CONSTRUCTION SERVICES, LLC is guilty of violating Section 17-25-103, Act 150 of 1965, as amended. (See Act 180 of 1985.)
JIMMY PERRY, d/b/a PERRY CONSTRUCTION SERVICES, LLC is guilty of violating Section 17-25-408 for failing to comply with the bonding requirements as set out in Section 17-25-404. (See Act 162 of 1987.)


ORDER

The Board voted unanimously that JIMMY PERRY, d/b/a PERRY CONSTRUCTION SERVICES, LLC shall pay a civil penalty of \$3,512 for violation of Act 150; \$5,854 for violation of Act 162 as amended for a total of \$9,366.00 to the Board, payable within twenty (20) days of receipt of this Order. The Board also issued a cease and desist order against JIMMY PERRY, d/b/a PERRY CONSTRUCTION SERVICES, LLC shall pay a civil penalty of \$3,512 for violation of Act 150; \$5,854 for violation of Act 162 as amended. JIMMY PERRY, d/b/a PERRY CONSTRUCTION SERVICES, LLC shall pay a civil penalty of \$3,512 for violation of Act 150; \$5,854 for violation of Act 162 as amended should refrain from bidding on or performing work on any projects in the amount of \$50,000.00 or more prior to being licensed with the Contractors Licensing Board and obtaining a

\$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.* You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 25-15-212.

**FINDINGS OF FACT,
CONCLUSIONS OF LAW AND ORDER**

A hearing on the above captioned matter was held before the Arkansas Contractors Licensing Board on November 15, 2024, at the Board's offices at 4100 Richards Road, North Little Rock, Arkansas.

Respondent, EVCO CONTRACTING, LLC was properly notified and did not appear. The Board was represented by Jonathan Hutto, Attorney. Dewey Watson served as Hearing Officer. From testimony and other evidence presented the Board makes the following findings of fact and conclusion of law.

FINDINGS OF FACT

1. EVCO CONTRACTING, LLC has undertaken the position of contractor as defined in Section 17-25-101 (Act 150 of 1965 as amended) and Section 17-25-401 (Act 162 of 1987 as amended), **RV Park in North Little Rock, AR.**
2. EVCO CONTRACTING, LLC is not licensed by the Contractors Licensing Board.
3. EVCO CONTRACTING, LLC has failed to obtain a \$10,000.00 surety bond or cash bond prior to commencing work as a contractor.
4. EVCO CONTRACTING, LLC entered into a contract to perform a commercial project in the amount of \$1,800,000. The contractor did not complete the project. The owner of the project later discovered that EVCO CONTRACTING, LLC had provided false references for the project and was unqualified to perform the work. There were 14 days of activity on the project.

CONCLUSIONS OF LAW

EVCO CONTRACTING, LLC is guilty of violating Section 17-25-103, Act 150 of 1965, as amended. (See Act 180 of 1985.)


EVCO CONTRACTING, LLC is guilty of violating Section 17-25-408 for failing to comply with the bonding requirements as set out in Section 17-25-404. (See Act 162 of 1987.)

ORDER

The Board voted unanimously that EVCO CONTRACTING, LLC shall pay a civil penalty of \$5,600 for violation of Act 150; \$90,000 for violation of act 162 as amended for a total of \$95,600.00 to the Board, payable within twenty (20) days of receipt of this Order. The Board further issued a cease and desist against EVCO CONTRACTING, LLC. EVCO CONTRACTING, LLC should refrain from bidding on or performing work on any projects in the amount of \$50,000.00 or more prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.* You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 25-15-212.

NOTICE OF CONTINUANCE OF HEARING


