The violation occurred on July 15, 2004. Mr. Grajeda paid the penalty without contest.

3. On April 18, 2005, Antonio Grajeda was assessed a civil money penalty in the amount \$300.00 for failure to provide adequate supervision for two (2) apprentices in violation of Regulation 7.9g of the Board. The amount of the penalty reflected that this was a second offense. The violations occurred on April 6, 2005. Mr. Grajeda paid the penalty without contest.

4. On May 21, 2005, an electrical inspection was conducted by the Department of Labor at 1908 Morter, Rogers, Arkansas. As a result of this inspection, Antonio Grajeda was assessed a civil penalty in the amount of \$3,000.00 for three (3) violations. This amount represents a penalty of \$1,000.00 for failure to provide adequate supervision for one (1) apprentice in violation of Regulation 7.9g of the Board and penalty of \$2,000.00 for allowing

two (2) individuals to perform electrical work in violation of Regulation 11.6 of the Board. The amount of the penalty reflected that this was a third offense.

5. By certified letter of June 3, 2005, Antonio Grajeda was notified of a hearing before the board on the \$3,000.00 civil penalty and a proposed license revocation. The hearing was scheduled for July 19, 2005 and held on that date. Mr. Grajeda was present at the hearing.

6. Department of Labor staff recommended that, in addition to the \$3,000.00 proposed civil penalty, Mr. Grajeda be placed on probation for a period of two years and that he be required to report the date and location of any Arkansas job or contract involving the performance of electrical work.

7. Mr. Grajeda did not dispute any of the facts or evidence presented by the agency.

CONCLUSIONS OF LAW:

1. Ark. Code Ann. § 17-28-304 has since July 1, 1998 prohibited any person from performing electrical work in the state unless the person is licensed by the Board of Electrical Examiners.

2. Regulation 7.9g of the Board of Electrical Examiners provides that "no...licensed electrician shall work an electrical apprentice except under the direct supervision of a journeyman or master electrician with a ratio not greater than two (2) apprentices to one (1) journeyman or one (1) master electrician on a construction project at any one time."

3. Regulation 11.6 of the Board of Electrical Examiners provides that "No person licensed by this board shall employ unlicensed persons or unregistered apprentices to perform electrical work. . ."

4. The Board is authorized to revoke or suspend a license for cause pursuant to Ark. Code Ann. § 17-28-202(a)(3). The Board is authorized to impose civil money penalties

pursuant to Ark. Code Ann. §17-28-309 and determines that the proposed civil penalty shall be assessed against Mr. Grajeda.

5. In lieu of a license revocation, the Board concludes that Antonio Grajeda shall be placed on probation for a period of two (2) years, dating from entry of this order, and that during this time, Antonio Grajeda shall report to the board in advance the date and location of any electrical work performed by Grajeda Electric, Inc. in Arkansas.

pursuant to Ark. Code Ann. §17-28-309 and determines that the proposed civil penalty shall be assessed against Mr. Worbington.

5. In lieu of a license revocation, the Board concludes that Steve Worbington shall be placed on probation for a period of two (2) years, dating from entry of this order, and that during this time, Steve Worbington shall report to the board in advance the date and location of any electrical work performed by Romac Electric, Inc. in Arkansas.

On this 19th day of July 2005, this matter comes before the Board of Electrical Examiners. On April 18, 2005, Antonio Grajeda (M-3434) was assessed a civil money penalty in the amount of \$300.00 for failure to provide adequate supervision for 2 apprentices in violation of Regulation 7.9g of the board. This violation occurred on April 6, 2005. Antonio Grajeda did not contest the penalty, but tendered payment on or about May 3, 2005.

The board approves the action taken in this matter.
