





ORDER

On the 20th day of September 2005, this matter comes before the Board of Electrical Examiners. Emery Crossland was present on his own behalf. Daniel Faulkner, Staff Attorney, represented the Department of Labor.

FINDINGS OF FACT:

1. Emery Crossland doing business as Emery Crossland Electric, 7011 Reece Road, Hensley, Arkansas, 72065 is licensed by the Arkansas Board of Electrical Examiners as a Master Electrician, License Number M-2136.

2. On May 25, 2005, Emery Crossland was assessed a civil money penalty in the amount of \$750.00 for allowing three (3) unlicensed individuals to perform electrical work in violation of Regulation 11.6 of the Board. The violation occurred on May 11, 2005. Mr. Crossland paid the penalty without contest on June 6, 2005. This penalty became final on July 19, 2005 upon approval by the Electrical Board

3. In August 2005, the Electrical Division received an application for licensure from Melvin Clark. This application contained an affidavit from Mr. Crossland indicating illegal work by Mr. Clark and an employment period of 1994 to 2005. As a result of this affidavit, Emery Crossland was assessed a civil penalty in the amount of \$750.00 for one (1) violation for allowing one (1) individual to perform electrical work in violation of Regulation 11.6 of the Board. The amount of the penalty reflected that this was a second offense.

4. By certified letter of August 15, 2005, Emery Crossland was notified of a hearing before the board on the proposed \$750.00 civil penalty. The hearing was scheduled for September 20, 2005 and held on that date. Mr. Crossland was present at the hearing.

5. Mr. Crossland did not dispute any of the facts or evidence presented by the agency. He further admitted that Mr. Clark has worked for Emery Crossland Electric continuously since assessment of the first civil penalty to the present.

CONCLUSIONS OF LAW:

1. Ark. Code Ann. § 17-28-304 has since July 1, 1998 prohibited any person from performing electrical work in the state unless the person is licensed by the Board of Electrical Examiners.

2. Regulation 11.6 of the Board of Electrical Examiners provides that "No person licensed by this board shall employ unlicensed persons or unregistered apprentices to perform electrical work. . ."

3. The Board is authorized to impose civil money penalties pursuant to Ark. Code Ann. §17-28-309 and determines that the proposed civil penalty shall be assessed against Mr. Crossland.

IT IS THEREFORE ORDERED that Emery Crossland shall pay a civil money penalty in the amount of **\$750.00** to the order of the Arkansas Department of Labor within ten (10) days of entry of this order.
