Disciplinary Hearing August 1, 2024

Case Number: 2024-06 in the matter of Clemmons v Justin Hall, PE REVOKED

Complaint: The Complaint alleges that Respondents Hall and Hall Engineering LTD performed engineering without a license.

Resolution: Respondents actions as described in the Findings of Facts violates Ark. Code Ann. § 17-30-301and § 17-30-301(4). Respondents were fined a civil penalty of \$5000

Consent Order May 14, 2024

Case Number: 2023-25 In the matter of Richardson v Cody Aaron Broadhead

Complaint: The complaint alleges that Broadhead practiced engineering in the State of Arkansas without a PE license. **Resolution**: Broadhead entered into a consent agreement with the Board admitting to violations of Ark. Code Ann. §17-30-102(b)(1) and Article 16(A)(1) of the Rules of the Board. Broadhead was assessed a fine of \$1000.

Case Number: 2023-19 & 2023-22 In the matter of Richardson & Springdale Water Utility v Thomas Appel **Complaint:** The complaint alleges misconduct in the practice of engineering.

Resolution: Appel entered into a consent agreement with the Board admitting to violations of Ark. Code Ann. § 17-30-305(a)(1)(K) Engaging in dishonorable, unethical, or unprofessional conduct of a character likely to deceive, defraud, or harm the public; \$500 Civil penalty and 6 hours of ethics courses.

Case Number: 2023-20 & 2023-24 In the matter of Richardson & Springdale Water Utility v Brandon Rush **Complaint:** The complaint alleges misconduct in the practice of engineering.

Resolution: Rush entered into a consent agreement with the Board admitting to violations of Ark. Code Ann. § 17-30-305(a)(1)(K) Engaging in dishonorable, unethical, or unprofessional conduct of a character likely to deceive, defraud, or harm the public; \$500 Civil penalty and 6 hours of ethics courses.

Consent Order September 11, 2024

Case Number: 2024-17 In the matter of Richardson v David C Wilbourn, PE 6441

Complaint: The complaint alleges that Broadhead practiced engineering in the State of Arkansas without a PE license. **Resolution**: Wilbourn entered into a consent agreement with the Board admitting to violations of Ark. Code Ann. §17-30-301, §17-30-301(4), and Article 16(A)(6) of the Rules of the Board. Wilbourn was assessed a fine of \$3000.
