

Arkansas State Board of Licensure
for Professional Engineers and Professional Surveyors
Minutes – June 17, 2025

A meeting of the Board was convened at 10:00 am in the Board Room at 623 Woodlane Dr., Little Rock, Arkansas by President David Beasley. Participants: Board Members, Donald Perry, Jared Wiley, Keith Sikes, Rodney Williams (ZOOM), Murry Cline (ZOOM), Brian Moore, (ZOOM), and Thomas Scott. Absent Kyle Salyer. Staff; Director Heather Richardson, Chief Investigator Grant Grigg, Assistant Director Linda Stone. Others; Administrative Hearing Officer Charles Moulton, Agency Counsel Sarah DeBusk-Griffith, Asst. Attorney General's Office, Court Reporter Melody Haley, Witness Kathrine Wilczek, PE, and from the Asst. Attorney General's Office Jessica Kloss and Andrew Kutchka.

President Beasley noted that a quorum was present and turned the meeting over to Charles Moulton. The Board is to consider the matter of Case 2024-19 Robert America, Non-Licensee. Complaint Committee Members Williams and Scott recused. At 10:10, the Hearing Officer noted that Mr. America was not present nor in the building.

After testimony by all parties, the following actions were taken:

- A. Findings of Facts and Allegations – motion made (Sikes moved, Perry seconded) and carried; that the numbers 1-11 are proven true (with "Deck 10" being changed to "Deck 1"); and
- B. Conclusions of law
 - a. Count 1 – motion made (Sikes moved, Cline seconded) and carried that Count 1 is proven true; and a Civil Penalty of \$5,000 is assessed and payable within 90 calendar days.
 - b. Count 2 – motion made (Sikes moved, Wiley seconded) and carried that Count 2 is proven true (with removal of text "engineer seal"); and a Civil Penalty of \$5,000 is assessed and payable within 90 calendar days.
 - c. Count 3 – motion made (Wiley moved, Perry seconded) and carried that Count 3 is proven true; and a Civil Penalty of \$5,000 is assessed and payable within 90 calendar days.
 - d. Count 4 – motion made (Wiley moved, Perry seconded) and carried that Count 4 is proven true (with "Deck 10" being changed to "Deck 1"); and a Civil Penalty of \$5,000 is assessed and payable within 90 calendar days.

At 10:55, the Hearing Officer noted that Mr. America was not present nor in the building. Closing instructions were provided and the Hearing record was closed. Business being thus concluded the meeting adjourned at 10:55 a.m.
