FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

A hearing on the above captioned matter was held before the Arkansas Residential Contractors Committee on April 23, 2025, at the Committee's offices at 4100 Richards Road, North Little Rock, Arkansas.

Respondent, BILL CALVEN, d/b/a NEA HOME IMPROVEMENTS was properly notified and did not appear. The Committee was represented by Jonathan Hutto, Attorney. Dewey Watson served as Hearing Officer. From testimony and other evidence presented the Committee makes the following findings of fact and conclusion of law.

FINDINGS OF FACT

- 1. This matter was initially heard on October 23, 2024. It was later determined that proper service of the notice of hearing for October 23, 2024, had not been obtained. The Committee set aside the finding of fact from the hearing on October 23, 2024.
- 2. BILL ČALVEN, d/b/a NEA HOME IMPROVEMENTS has undertaken the position of residential contractor as defined in Section 17-25-505, a home improvement project in Jonesboro. AR.
- 3. BILL CALVEN, d/b/a NEA HOME IMPROVEMENTS is not licensed by the Residential Contractors Committee.
- 4. Our office received a complaint from Christyn Greenhaw against BILL CALVEN, d/b/a NEA HOME IMPROVEMENTS stating that she had hired the contractor to perform a home improvement project for \$2,800 but the contractor abandoned the project prior to completion. There were 20 days of activity on the project.

CONCLUSIONS OF LAW

BILL CALVEN, d/b/a NEA HOME IMPROVEMENTS is guilty of violating Section 17-25-505, as amended.

ORDER

The Committee voted unanimously that BILL CALVEN, d/b/a NEA HOME IMPROVEMENTS shall pay a civil penalty of \$400 per day for 20 days of activity for a total of \$8,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against BILL CALVEN, d/b/a NEA HOME IMPROVEMENTS to prevent them from performing work in violation. BILL CALVEN, d/b/a NEA HOME IMPROVEMENTS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

It was continued until April 23, 2025, to obtain additional testimony. The hearing was concluded on April 23, 2025.

Respondent, MIKE WALLACE, d/b/a M. WALLACE CONSTRUCTION LLC was properly notified and did appear. The Committee was represented by Jonathan Hutto, Attorney. Dewey Watson served as Hearing Officer. From testimony and other evidence presented the Committee makes the following findings of fact and conclusion of law.

FINDINGS OF FACT

- 1. MIKE WALLACE, d/b/a M. WALLACE CONSTRUCTION LLC has undertaken the position of residential contractor as defined in Section 17-25-505, **Home Improvement in Hot Springs**National Park, AR.
- 2. MIKE WALLACE, d/b/a M. WALLACE CONSTRUCTION LLC is not licensed by the Residential Contractors Committee.
- 3. Our office received a complaint from Winifred Smith against MIKE WALLACE, d/b/a M. WALLACE CONSTRUCTION LLC . MIKE WALLACE, d/b/a M. WALLACE CONSTRUCTION LLC entered into a contract with Winifred Smith, the owner of a home, to build and install cabinets. Ms. Smith paid MIKE WALLACE, d/b/a M. WALLACE CONSTRUCTION LLC for his work. There were issues with the project. There were 160 days of activity on the project.

CONCLUSIONS OF LAW

MIKE WALLACE, d/b/a M. WALLACE CONSTRUCTION LLC is guilty of violating Section 17-25-505, as amended.

ORDER

The Committee voted 2 to 1 that MIKE WALLACE, d/b/a M. WALLACE CONSTRUCTION LLC shall pay a civil penalty of \$100 per day for 160 days of activity for a total of \$16,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against MIKE WALLACE, d/b/a M. WALLACE CONSTRUCTION LLC to prevent them from performing work in violation. MIKE WALLACE, d/b/a M. WALLACE CONSTRUCTION LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

CONCLUSIONS OF LAW

DERECK ROBINSON, d/b/a SECOND CHANCE CONSTRUCTION is guilty of violating Section 17-25-505, as amended.

ORDER

The Committee voted unanimously that DERECK ROBINSON, d/b/a SECOND CHANCE CONSTRUCTION shall pay a civil penalty of \$400 per day for 53 days for a total of \$21,200 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against DERECK ROBINSON, d/b/a SECOND CHANCE CONSTRUCTION to prevent them from performing work in violation. DERECK ROBINSON, d/b/a SECOND CHANCE CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. - 3. Our office received a complaint from Charles Snyder stating that he had hired AUBREY 'AJ" JOHNSON, d/b/a NEW IMAGE OF ARKANSAS to perform a home improvement project. There were several contracts which totaled almost \$100,000. The work was poor and Mr. Snyder received a judgment against AUBREY 'AJ" JOHNSON, d/b/a NEW IMAGE OF ARKANSAS in the amount of \$66,650.43 plus costs and fees. There were 60 days of work on the project.

CONCLUSIONS OF LAW

AUBREY 'AJ" JOHNSON, d/b/a NEW IMAGE OF ARKANSAS is guilty of violating Section 17-25-505, as amended.

ORDER

The Committee voted unanimously that AUBREY 'AJ" JOHNSON, d/b/a NEW IMAGE OF ARKANSAS shall pay a civil penalty of \$400 per day for 60 days of activity for a total of \$24,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against AUBREY 'AJ" JOHNSON, d/b/a NEW IMAGE OF ARKANSAS to prevent them from performing work in violation. AUBREY 'AJ" JOHNSON, d/b/a NEW IMAGE OF ARKANSAS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. FINDINGS OF FACT

- 1. NTEGRITY WINDOWS, LLC is licensed by the Residential Contractors Committee.
- 2. Our office received a complaint against NTEGRITY WINDOWS, LLC from AJ Martlin stating that they had entered into a contract with NTEGRITY WINDOWS, LLC for a home improvement project for \$9,450 and paid \$2,900 down. No work was ever performed and no money was ever returned.
- 3. Our office received a complaint from Tim and Vicki Hughes against NTEGRITY WINDOWS, LLC. The Hughes' had entered into a contract with NTEGRITY WINDOWS, LLC in the amount of \$29,850.24 and had paid \$14,355 down on the project. No work was ever performed and no money was ever returned.

CONCLUSIONS OF LAW

NTEGRITY WINDOWS, LLC is guilty of violating Section 17-25-510(c), misconduct in the contractors business.

ORDER

The Committee voted unanimously that the license of NTEGRITY WINDOWS, LLC is revoked for misconduct. The Committee further ordered that a cease and desist order be issued against NTEGRITY WINDOWS, LLC to prevent them from performing work in violation. NTEGRITY WINDOWS, LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

- 2. The Contractors Licensing Board became aware of a judgment against DUSTIN KEATHLEY, d/b/a DR KEATHLEY HOMES by Dean and Christie Halijan which had been obtained on June 3, 2024. The initial litigatation began in 2022. A contractor is required to disclose pending litigation at the time of renewal but DUSTIN KEATHLEY, d/b/a DR KEATHLEY HOMES did not do so. This failure to disclose information as required constitutes misconduct in the contractors business.

CONCLUSIONS OF LAW

DUSTIN KEATHLEY, d/b/a DR KEATHLEY HOMES is guilty of violating Section 17-25-510(c), as amended.

ORDER

The Committee voted unanimously that a letter of reprimand be issued to DUSTIN KEATHLEY, d/b/a DR KEATHLEY HOMES and that he shall pay a civil penalty of \$500 payable to the Committee within twenty (20) days. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.

- 2. Our office received a new application for residential builder from BEDWELL ALL IN 1 LLC. While processing the application we became aware of a bankruptcy that was filed and never disclosed and criminal history from 2017 and 2019 that had never been disclosed.
- 3. Contractors are required to disclose any litigation, bankruptcy, or criminal history at the time they apply and on each renewal application. BEDWELL ALL IN 1 LLC did not disclose these things.

CONCLUSIONS OF LAW

BEDWELL ALL IN 1 LLC is guilty of violating Section 17-25-510(c), as amended.

ORDER

The Committee voted unanimously that the license of BEDWELL ALL IN 1 LLC is revoked for misconduct. The Committee further ordered that a cease and desist order be issued against BEDWELL ALL IN 1 LLC to prevent them from performing work in violation. BEDWELL ALL IN 1 LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.
