ARKANSAS CONTRACTORS LICENSING BOARD

vs

BRYAN GRAHAM, D/B/A PROFESSIONAL CABINET AND TRIM

ORDER

The Board voted unanimously that Bryan Graham, d/b/a Professional Cabinet and Trim shall pay a civil penalty of \$3,540.00 for violation of Act 150; \$5,900.00 for violation of Act 162 as amended for a total of \$9,290.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

RICHARD D. MASSEY, JR., D/B/A COMPLETE EXTERIOR RENOVATIONS

ORDER

The Board voted unanimously that Richard D. Massey, Jr., d/b/a Complete Exterior Renovations shall pay a civil penalty of \$1,335.00 for violation of Act 150; \$2,225.00 for violation of Act 162 as amended for a total of \$3,560.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

vs

S & S FRAMING, LLC

ORDER

The Board voted unanimously that S & S Framing, LLC shall pay a civil penalty of \$30,330.00 for violation of Act 150 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

TEAM GENERAL CONTRACTING, LLC

ORDER

The Board voted unanimously that Team General Contracting, LLC shall pay a civil penalty of \$351.00 for using unlicensed subcontractors to the Board payable within twenty (20) days of receipt of this Order and refrain from aiding or abetting or using contractors in violation of the contractors licensing law.
