### **ORDER**

A hearing on the above captioned matter was held before the Arkansas Contractors Licensing Board on February 28, 2025, at the Boards offices at 4100 Richards Road, North Little Rock, Arkansas.

Appellant, MICHAEL WALLACE, D/B/A ABSOLUTE PAINT, did appear and was represented by attorney Harrison Kemp. The Board was represented by Jonathan Hutto, Attorney. Dewey Watson served as Hearing Officer. From a review of the transcript and considering the arguments of the parties, Board finds as follows:

- 1. MICHAEL WALLACE, D/B/A ABSOLUTE PAINT was charged with acting as a residential contractor without a contractors license, Ark. Code Ann. §17-25-05.
- 2. The Arkansas Residential Contractors Committee held a hearing on August 21, 2024, concerning the alleged violation of MICHAEL WALLACE, D/B/A ABSOLUTE PAINT.
- 3. The Committee found MICHAEL WALLACE, D/B/A ABSOLUTE PAINT in violation of §17-25-505, as amended and an assessed a civil penalty of \$6,000 and issued a cease and desist.
- 4. MICHAEL WALLACE, D/B/A ABSOLUTE PAINT timely appealed the decision of the Residential Committee to the Arkansas Contractors Licensing Board.
- 5. Upon review of the record, the Board finds that there was substantial evidence to support the finding of a violation but modified the penalty to \$6,000 but suspended that penalty if the contractor obtained a license within 60 days.

WHEREFORE, by a unanimous vote the Board does affirm the finding of a violation and modifies the decision of the Residential Committee to \$6,000 suspended if the contractor obtains a license within 60 days. MICHAEL WALLACE, D/B/A ABSOLUTE PAINT is ordered to pay to the Residential Contractors Committee the cost of the transcript, \$154.65. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-409.

### **CONCLUSIONS OF LAW**

#### **ORDER**

The Committee voted unanimously that CLAY LEWALLEN, d/b/a CJ'S REMODELING shall pay a civil penalty of \$400 per day for 14 days of activity of both projects for a total of \$5,600 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. - 5. KENNY EVERETT, d/b/a KJE CONSTRUCTION had had one previous violation for working on a residential project without a license. He entered into a settlement agreement on November 10, 2021, in the amount of \$5,200 reduced to \$300 if there were no further violations for 3 years, he pay any judgment obtained by the homeowner in that case, and he pay that penalty as agreed. KENNY EVERETT, d/b/a KJE CONSTRUCTION did pay that penalty.

## **CONCLUSIONS OF LAW**

KENNY EVERETT, d/b/a KJE CONSTRUCTION is guilty of violating Section 17-25-505, as amended.

Respondent, CHRIS HAWKINS, d/b/a HAWKINS REMODEL was properly notified and did not appear. The Committee was represented by Jonathan Hutto, Attorney. Dewey Watson served as Hearing Officer. From testimony and other evidence presented the Committee makes the following findings of fact and conclusion of law.

### FINDINGS OF FACT

- 1. CHRIS HAWKINS, d/b/a HAWKINS REMODEL has undertaken the position of residential contractor as defined in Section 17-25-505, **Home Improvement in Rudy, AR.**
- 2. CHRIS HAWKINS, d/b/a HAWKINS REMODEL is not licensed by the Residential Contractors Committee.
- 3. Our office received a complaint from Carrie Canady against CHRIS HAWKINS, d/b/a HAWKINS REMODEL stating that she had hired the contractor to perform a home improvement project and paid \$10,000 but the contractor abandoned the project prior to completion. There were 5 days of activity on the project.

## **CONCLUSIONS OF LAW**

CHRIS HAWKINS, d/b/a HAWKINS REMODEL is guilty of violating Section 17-25-505, as amended.

#### **ORDER**

The Committee voted unanimously that CHRIS HAWKINS, d/b/a HAWKINS REMODEL shall pay a civil penalty of \$400 per day for 5 days of activity for a total of \$2,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against CHRIS HAWKINS, d/b/a HAWKINS REMODEL to prevent them from performing work in violation. CHRIS HAWKINS, d/b/a HAWKINS REMODEL shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. Mr. Arana also provided a statement from a licensed builder who stated that the structural issues could not be fixed and the building should be removed and rebuilt.
- 4. DYLAN DUOS, d/b/a LUX RESTORE testified that he did not have a license and that there were 90 days of activity on the project.

## **CONCLUSIONS OF LAW**

DYLAN DUOS, d/b/a LUX RESTORE is guilty of violating Section 17-25-505, as amended.

#### ORDER

The Committee voted unanimously that DYLAN DUOS, d/b/a LUX RESTORE shall pay a civil penalty of \$400 per day for 90 days of activity for a total of \$36,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. ### **CONCLUSIONS OF LAW**

BIC CONSTRUCTION LLC is guilty of violating Section 17-25-505, as amended.

#### ORDER

The Committee voted 4 to 1 that BIC CONSTRUCTION LLC shall pay a civil penalty of \$400 per day for 180 days of activity reduced to \$1,000 if there are no further violations for 3 years and they obtain their residential home builder's license for violation of Section 17-25-505 payable to the Committee within twenty (20) days. BIC CONSTRUCTION LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. HARDIN, d/b/a BUILD IT CONSTRUCTION stating she had hired him to perform a project and he performed the electrical work himself without a license. In a response, JOHN W. HARDIN, d/b/a BUILD IT CONSTRUCTION admitted to installing electrical without a license. There were several electrical code violations on the project. The cost of the project was \$88,316.
- 3. In November 2024, Ms. Moyer received a default judgment against JOHN W. HARDIN, d/b/a BUILD IT CONSTRUCTION in the amount of \$57,205 plus attorney fees and costs. When contacted by this office about how he intended to resolve the default judgment, JOHN W. HARDIN, d/b/a BUILD IT CONSTRUCTION had no plan and has made no arrangements with Ms. Moyer to pay the judgment.

### **CONCLUSIONS OF LAW**

JOHN W. HARDIN, d/b/a BUILD IT CONSTRUCTION is guilty of violating Section 17-25-10(c), misconduct in the contractor's business.

#### **ORDER**

The Committee voted unanimously that the license of JOHN W. HARDIN, d/b/a BUILD IT CONSTRUCTION is revoked for msiconduct. The Committee further ordered that a cease and desist order be issued against JOHN W. HARDIN, d/b/a BUILD IT CONSTRUCTION to prevent them from performing work in violation. JOHN W. #### **ORDER**

The Committee voted unanimously that JERRY CURRY, d/b/a CURRY CONSTRUCTION shall pay a civil penalty of \$400 per day for 200 days of activity for a total of \$80,000 for violation of Section 17-25-505. The penalty shall be reduced to \$10,000 if it is paid within 60 days. The Committee further ordered that a cease and desist order be issued against JERRY CURRY, d/b/a CURRY CONSTRUCTION to prevent them from performing work in violation. Respondent, SGC INC was properly notified and did not appear. The Committee was represented by Jonathan Hutto, Attorney. Dewey Watson served as Hearing Officer. From testimony and other evidence presented the Committee makes the following findings of fact and conclusion of law.

## FINDINGS OF FACT

1. SGC INC is licensed by the Residential Contractors Committee as with a home improvement specialty license.

2. Our office received a complaint from Rosalind Gilliam against SGC INC stating that she had entered into a contract with them to perform a home improvement project for \$18,000 but the contractor was actually paid \$21,200. There were many issues with the project including the concrete being wavy, improperly sloped and holding water. The contractor refused to return to the project and correct these issues. SGC INC also failed to return any telephone calls to our office to discuss this issue.

## **CONCLUSIONS OF LAW**

SGC INC is guilty of violating Section 17-25-510(c) misconduct in the contractor's business.

#### ORDER

The Committee voted unanimously that the license of SGC INC is revoked for misconduct. The Committee further ordered that a cease and desist order be issued against SGC INC to prevent them from performing work in violation. SGC INC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 17-25-511.
