## FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

A hearing on the above captioned matter was held before the Arkansas Contractors Licensing Board on January 24, 2025, at the Boards offices at 4100 Richards Road, North Little Rock, Arkansas.

Respondent, R L JACKSON'S CONSTRUCTION COMPANY LLC was properly notified and Rickey Jackson did appear. The Board was represented by Jonathan Hutto, Attorney. Dewey Watson served as Hearing Officer. From testimony and other evidence presented the Board makes the following findings of fact and conclusion of law.

### FINDINGS OF FACT

- 1. R L JACKSON'S CONSTRUCTION COMPANY LLC is licensed by the Contractors Licensing Board.
- 2. Our office received a complaint from JT White Lumber Co., LLC against R L JACKSON'S CONSTRUCTION COMPANY LLC stating that they had received a judgment in the amount of \$31,364.15. The parties had reached a payment arrangement toward the judgment but R L JACKSON'S CONSTRUCTION COMPANY LLC had failed to make any payment since July 2024 and had not contacted JT White since that time about his inability to pay or made any other arrangements with them.
- 3. R L JACKSON'S CONSTRUCTION COMPANY LLC stated that it intended to resume payments to JT White in February 2025.

## CONCLUSIONS OF LAW

R L JACKSON'S CONSTRUCTION COMPANY LLC is guilty of violating Section 17-25-308 misconduct in the conduct of the contractor's business.

#### **ORDER**

The Board voted unanimously that the license of R L JACKSON'S CONSTRUCTION COMPANY LLC is revoked for misconduct. This revocation is suspended provided the contractor makes consistent payments to JT White for 6 months beginning February 2025. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 25-15-212.

## FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

The Board was represented by Jonathan Hutto, Attorney. Dewey Watson served as Hearing Officer. From testimony and other evidence presented the Board makes the following findings of fact and conclusion of law.

### FINDINGS OF FACT

- 1. ELITE EXTERIORS, ROOFING AND RESTORATION, INC. is licensed by the Contractors Licensing Board.
- 2. The Contractors Board became aware of pending lawsuits that were filed against ELITE EXTERIORS, ROOFING AND RESTORATION, INC. but never disclosed when they submitted their renewal application. A contractor is required at the time of renewal to disclose any liens, judgments, or pending litigation is is informed that failure to do so could result in the revocation of a contractors license.
- 3. In addition to the litigation that was not disclosed, ELITE EXTERIORS, ROOFING AND RESTORATION, INC. has 8 complaints filed against it. Previous related entities have more complaints, violations, and have provided the Board with checks that were returned as insufficient.

# CONCLUSIONS OF LAW

ELITE EXTERIORS, ROOFING AND RESTORATION, INC. is guilty of violating Section 17-25-308 misconduct in the conduct of the contractor's business

### **ORDER**

The Board voted unanimously that the license of ELITE EXTERIORS, ROOFING AND RESTORATION, INC. is revoked for misconduct. This revocation is suspended if there are no further violations for 1 year. You have the right to appeal this decision pursuant to the provisions of Ark. Code Ann. 25-15-212.
