Arkansas Towing & Recovery Board • January 29, 2025

The Arkansas Towing & Recovery Board convened on Tuesday, January 29, 2025, at 9:30 a.m. The meeting was held at the Arkansas Department of Labor and Licensing at 900 West Capitol Avenue, Suite 400, Little Rock, Arkansas, 72201.

2024-0715: A1's Towing & Hauling (Represented by Council). Request for continuance by Respondent. Case was continued until next hearing date. Motion by Ross. Seconded by Brown. Motion carried 7-0.
