ADMINISTRATIVE HEARING

On February 8, 2011, the Board of Licensure for Professional Engineers and Professional Surveyors (hereinafter “the Board”) held an administrative hearing to consider the referenced matter. Finding proper notice had been given the Respondent, and after considering all evidence presented, the Board issues the following Findings of Fact, Conclusions of Law, and Order:

FINDINGS OF FACT

1. Jones does not now, nor has he ever, held licensure as a Professional Engineer in Arkansas.
2. Jones was an employee of a firm which was retained to plan, execute, and report the results of an environmental site investigation.
3. Jones prepared certain documents for the site investigation plan and report.
4. On the flysheet of the site investigation report under the “Prepared by” heading, Jones is listed as the “Project Engineer,” and there is a signature fixed above the “Project Engineer” notation which appears to be the same as that fixed to his Answer to the complaint.

CONCLUSIONS OF LAW


The conduct of the Respondent, as outlined in the Findings of Fact above, constitutes one count of practicing or offering to practice engineering without licensure by the Board, in violation of Arkansas Code Annotated §17-30-102(b).

ORDER

Based on these Findings and Conclusions, the Respondent shall pay to the Board a civil penalty of \$1,000 for the violation described in the Conclusions of Law above.

Payment must be submitted within fifty (50) days of the service of this Order.
