IN RE: KEAGAN SANDS – REQUEST FOR LICENSE REINSTATMENT

## ORDER

This matter came before the Board of Electrical Examiners ("Board") on Tuesday, May 20, 2025. The petitioner, Keagan Sands ("Petitioner"), seeks approval to reinstate his residential journeyman license after his license was revoked by the Board on January 18, 2023. The Board has authority to reinstate a license after a revocation in accordance with the Administrative Rules of the Board of Electrical Examiners, State of Arkansas Rule 010.13-014(I)(1-5) & (J)(1-5). Petitioner appeared in person for the hearing.

## FINDING OF FACT

- 1. Petitioner is requesting approval by the Board to reinstate his residential journeyman license.
- 2. Petitioner is ineligible to obtain his residential journeyman license because his residential journeyman license was revoked by the Board on January 18, 2023.
  - 3. Petitioner's residential journeyman license has been revoked for a period of two years.
  - 4. Petitioner appeared in person before the Board for the hearing.
  - 5. The Board heard testimony from Petitioner and reviewed the documents he submitted.
  - 6. The Board reviewed Petitioner's case file from January 18, 2023.

## CONCLUSIONS OF LAW

1. The Board has authority to reinstate a license after a revocation in accordance with the Administrative Rules of the Board of Electrical Examiners, State of Arkansas Rule 010.13-014(I)(1-5) & (J)(1-5).

2. A basis upon which the Board may grant such a request includes without limitation:

a. The application for re-licensure has been filed by the applicant at least two (2) years

after the revocation took place;

b. The applicant has shown he or she is rehabilitated;

c. The applicant has shown he or she can engage in the conduct authorized by the license

without undue risk to the public health, safety, and welfare; and

d. The applicant is otherwise qualified for the license.

3. The Board may require the applicant seeking re-licensure to take the licensing exam.

4. The Board reviewed Petitioner's case that led its decision to revoke his residential

journeyman license on January 18, 2023.

5. The Board was satisfied with the information Petitioner provided, reviewed all documents

pertaining to the re-licensure request, and voted to grant Petitioner's request to reinstate his

residential journeyman license after Petitioner passes the licensing exam for his residential

journeyman license.

THEREFORE, the Board grants Petitioner's request for his residential journeyman license to

be reinstated after he passes the residential journeyman exam.

IT IS SO ORDERED.
