DISCIPLINARY HEARING

On July 27, 2010, the Board of Licensure for Professional Engineers and Professional Surveyors (hereinafter "the Board") held a formal hearing to consider the referenced matter. Finding proper notice had been given the Respondent, and after considering all evidence presented, the Board issues the following Findings of Fact, Conclusions of Law, and Order:

FINDINGS OF FACT

- 1. At the time of the complaint the Respondent was a licensed Professional Surveyor, and the Board has jurisdiction over his conduct and the subject matter of this complaint.
- 2. On or about May 19, 2009, Wheeler entered a "no contest" plea to a felony offense in Van Buren County.

CONCLUSIONS OF LAW

Arkansas Code Annotated §17-48-205(3) provides that the Board shall revoke the license of any Professional Surveyor if, after a hearing, the licensee has been convicted of a felony or crime of moral turpitude.

ORDER

Based on these Findings and Conclusions, the Professional Surveyor license of the Respondent is revoked.


